- Narrow networks

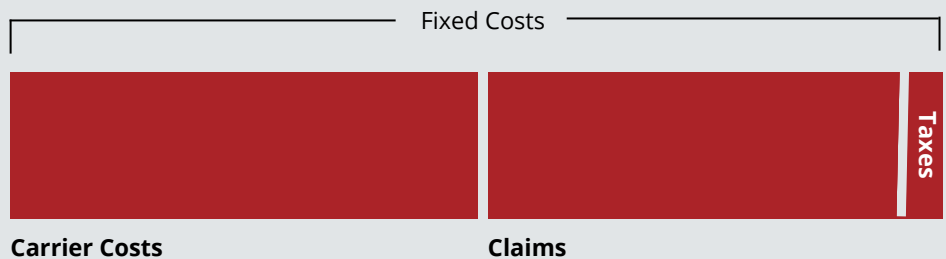

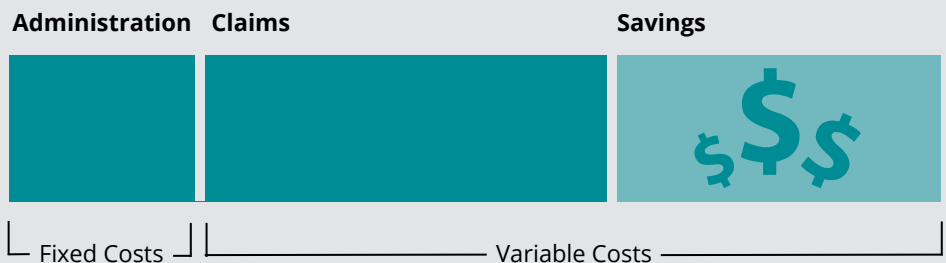

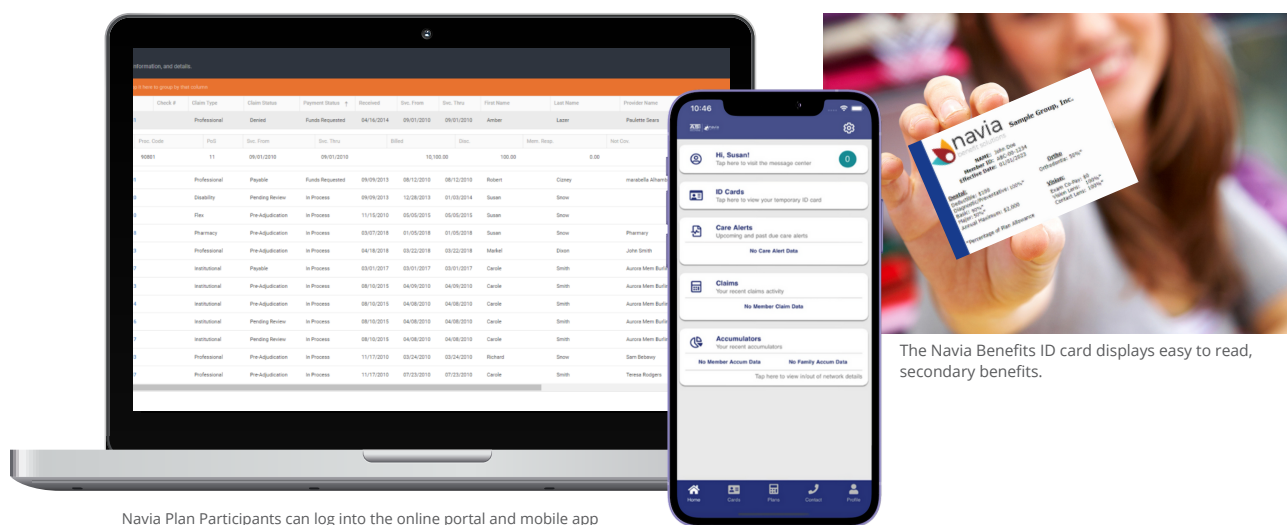
